

SMOOTH FRACTAL INTERPOLATION

Fractal methodology provides a general frame for the understanding of real-world phenomena. In particular, the classical methods of real-data interpolation can be generalized by means of fractal techniques. In this paper, we describe a procedure for the construction of smooth fractal functions, with the help of Hermite osculatory polynomials. As a consequence of the process, we generalize any smooth interpolant by means of a family of fractal functions. In particular, the elements of the class can be defined so that the smoothness of the original is preserved. Under some hypotheses, bounds of the interpolation error for function and derivatives are obtained. A set of interpolating mappings associated to a cubic spline is defined and the density of fractal cubic splines in $\mathcal{H}^2[a, b]$ is proven.

1. Introduction

Fractal interpolation techniques provide good deterministic representations of complex phenomena. Barnsley [2, 3] and Hutchinson [8] were pioneers in the use of fractal functions to interpolate sets of data. Fractal interpolants can be defined for any continuous function defined on a real compact interval. This method constitutes an advance in the techniques of approximation, since all the classical methods of real-data interpolation can be generalized by means of fractal techniques (see, e.g., [5, 10, 12]).

Fractal interpolation functions are defined as fixed points of maps between spaces of functions using iterated function systems. The theorem of Barnsley and Harrington (see [4]) proves the existence of differentiable fractal interpolation functions. However, in some cases, it is difficult to find an iterated function system satisfying the hypotheses of the theorem, mainly whenever some specific boundary conditions are required (see [4]). In this paper, we describe a very general way of constructing smooth fractal

functions with the help of Hermite osculatory polynomials. The proposed method solves the problem with the help of a classical interpolant. The fractal solution is unique and the constructed interpolant preserves the prefixed boundary conditions. The procedure has a computational cost similar to that of the classical method.

As a consequence of the process, we generalize any smooth interpolant by means of a family of fractal functions. Each element of the class preserves the smoothness and the boundary conditions of the original. Under some hypotheses, bounds of the interpolation error for function and derivatives are obtained. Assuming some additional conditions on the scaling factors, the convergence is also preserved.

In the last section, a set of interpolating mappings associated to a cubic spline is defined, in the general frame of functions whose second derivative has an integrable square. In particular, the density of fractal cubic splines in $\mathcal{H}^2[a, b]$ is proven.

2. Construction of smooth fractal interpolants

2.1. Fractal interpolation functions. Let $t_0 < t_1 < \dots < t_N$ be real numbers, and $I = [t_0, t_N] \subset \mathbb{R}$ the closed interval that contains them. Let a set of data points $\{(t_i, x_i) \in I \times \mathbb{R} : i = 0, 1, 2, \dots, N\}$ be given. Set $I_n = [t_{n-1}, t_n]$ and let $L_n : I \rightarrow I_n$, $n \in \{1, 2, \dots, N\}$, be contractive homeomorphisms such that

$$L_n(t_0) = t_{n-1}, \quad L_n(t_N) = t_n, \quad (2.1)$$

$$|L_n(c_1) - L_n(c_2)| \leq l |c_1 - c_2| \quad \forall c_1, c_2 \in I \quad (2.2)$$

for some $0 \leq l < 1$.

Let $-1 < s_n < 1$, $n = 1, 2, \dots, N$, and $F = I \times \mathbb{R}$, let N be continuous mappings, let $F_n : F \rightarrow \mathbb{R}$ be given satisfying

$$F_n(t_0, x_0) = x_{n-1}, \quad F_n(t_N, x_N) = x_n, \quad n = 1, 2, \dots, N, \quad (2.3)$$

$$|F_n(t, x) - F_n(t, y)| \leq |s_n| |x - y|, \quad t \in I, x, y \in \mathbb{R}. \quad (2.4)$$

Now define functions

$$w_n(t, x) = (L_n(t), F_n(t, x)) \quad \forall n = 1, 2, \dots, N, \quad (2.5)$$

and consider the following theorem.

THEOREM 2.1 [2, 3]. *The iterated function system (IFS) $\{F, w_n : n = 1, 2, \dots, N\}$ defined above admits a unique attractor G . G is the graph of a continuous function $f : I \rightarrow \mathbb{R}$ which obeys $f(t_i) = x_i$ for $i = 0, 1, 2, \dots, N$.*

The previous function f is called a fractal interpolation function (FIF) corresponding to $\{(L_n(t), F_n(t, x))\}_{n=1}^N$. $f : I \rightarrow \mathbb{R}$ is the unique function satisfying the functional equation

$$f(L_n(t)) = F_n(t, f(t)), \quad n = 1, 2, \dots, N, t \in I, \quad (2.6)$$

or

$$f(t) = F_n(L_n^{-1}(t), f \circ L_n^{-1}(t)), \quad n = 1, 2, \dots, N, \quad t \in I_n = [t_{n-1}, t_n]. \quad (2.7)$$

Let \mathcal{F} be the set of continuous functions $f: [t_0, t_N] \rightarrow \mathbb{R}$ such that $f(t_0) = x_0$, $f(t_N) = x_N$. Define a metric on \mathcal{F} by

$$d(f, g) = \|f - g\|_\infty = \max\{|f(t) - g(t)|; t \in [t_0, t_N]\} \quad \forall f, g \in \mathcal{F}. \quad (2.8)$$

Then (\mathcal{F}, d) is a complete metric space.

Define a mapping $T: \mathcal{F} \rightarrow \mathcal{F}$ by

$$(Tf)(t) = F_n(L_n^{-1}(t), f \circ L_n^{-1}(t)) \quad \forall t \in [t_{n-1}, t_n], \quad n = 1, 2, \dots, N. \quad (2.9)$$

Using (2.1)–(2.4), it can be proved that $(Tf)(t)$ is continuous on the interval $[t_{n-1}, t_n]$ for $n = 1, 2, \dots, N$ and at each of the points t_1, t_2, \dots, t_{N-1} . T is a contractive mapping on the metric space (\mathcal{F}, d) ,

$$\|Tf - Tg\|_\infty \leq |s|_\infty \|f - g\|_\infty, \quad (2.10)$$

where $|s|_\infty = \max\{|s_n|; n = 1, 2, \dots, N\}$. Since $|s|_\infty < 1$, T possesses a unique fixed point on \mathcal{F} , that is to say, there is $f \in \mathcal{F}$ such that $(Tf)(t) = f(t)$ for all $t \in [t_0, t_N]$. This function is the FIF corresponding to w_n .

The most widely studied fractal interpolation functions so far are defined by the following IFS:

$$\begin{aligned} L_n(t) &= a_n t + b_n, \\ F_n(t, x) &= s_n x + q_n(t) \end{aligned} \quad (2.11)$$

with

$$a_n = \frac{(t_n - t_{n-1})}{(t_N - t_0)}, \quad b_n = \frac{(t_N t_{n-1} - t_0 t_n)}{(t_N - t_0)}. \quad (2.12)$$

s_n is called the vertical scaling factor of the iterated function system and $s = (s_1, s_2, \dots, s_N)$ is the scale vector of the transformation. If $q_n(t)$ are linear for $t \in [t_0, t_N]$ then the FIF is called affine (AFIF) (see [2, 11]). The cubic FIF (see [10, 13]) is constructed using $q_n(t)$ as a cubic polynomial.

In many cases, the data are evenly sampled, then

$$\begin{aligned} h &= t_n - t_{n-1}, \\ t_N - t_0 &= Nh. \end{aligned} \quad (2.13)$$

In the particular case, $s_n = 0$ for all $n = 1, 2, \dots, N$, then

$$F_n(t, x) = q_n(t) \quad (2.14)$$

and $f(t) = q_n \circ L_n^{-1}(t)$ for all $t \in I_n$.

2.2. Differentiable fractal interpolation functions. In this section, we study the construction of smooth fractal interpolation functions. The theorem of Barnsley and Harrington [4] proves the existence of differentiable FIFs and gives the conditions for their existence. We look for IFS satisfying the hypotheses of this theorem.

THEOREM 2.2 (Barnsley and Harrington [4]). *Let $t_0 < t_1 < t_2 < \dots < t_N$ and $L_n(t)$, $n = 1, 2, \dots, N$, the affine function $L_n(t) = a_n t + b_n$ satisfying the expressions (2.1)-(2.2). Let $a_n = L'_n(t) = (t_n - t_{n-1})/(t_N - t_0)$ and $F_n(t, x) = s_n x + q_n(t)$, $n = 1, 2, \dots, N$, verifying (2.3)-(2.4). Suppose for some integer $p \geq 0$, $|s_n| < a_n^p$, and $q_n \in \mathcal{C}^p[t_0, t_N]$; $n = 1, 2, \dots, N$. Let*

$$F_{nk}(t, x) = \frac{s_n x + q_n^{(k)}(t)}{a_n^k}, \quad k = 1, 2, \dots, p, \quad (2.15)$$

$$x_{0,k} = \frac{q_1^{(k)}(t_0)}{a_1^k - s_1}, \quad x_{N,k} = \frac{q_N^{(k)}(t_N)}{a_N^k - s_N}, \quad k = 1, 2, \dots, p. \quad (2.16)$$

If $F_{n-1,k}(t_N, x_{N,k}) = F_{nk}(t_0, x_{0,k})$ with $n = 2, 3, \dots, N$ and $k = 1, 2, \dots, p$, then

$$\{(L_n(t), F_n(t, x))\}_{n=1}^N \quad (2.17)$$

determines a FIF $f \in \mathcal{C}^p[t_0, t_N]$ and $f^{(k)}$ is the FIF determined by

$$\{(L_n(t), F_{nk}(t, x))\}_{n=1}^N \quad (2.18)$$

for $k = 1, 2, \dots, p$.

From here on, we consider a uniform partition in order to simplify the calculus. In this case,

$$a_n = \frac{1}{N}. \quad (2.19)$$

If we consider a generic polynomial q_n , for instance, the equality proposed in the theorem implies the resolution of systems of equations. Sometimes the system has no solution, mainly whenever some boundary conditions are imposed on the function (see [4]). We will proceed in a different way. In order to define an IFS satisfying Theorem 2.2, we consider the following mappings:

$$\begin{aligned} L_n(t) &= a_n t + b_n, \\ F_n(t, x) &= s_n x + q_n(t), \end{aligned} \quad (2.20)$$

where

$$q_n(t) = g \circ L_n(t) - s_n b(t), \quad (2.21)$$

g is a continuous function satisfying

$$g(t_i) = x_i, \quad i = 0, 1, \dots, N, \quad (2.22)$$

and $b(t)$ is a real continuous function, $b \neq g$, such that

$$b(t_0) = x_0, \quad b(t_N) = x_N. \tag{2.23}$$

The IFS satisfies the hypotheses (2.1)–(2.5) of Barnsley’s theorem (see [11]). In [11], we proved some properties of this fractal function.

Definition 2.3. Consider $g \in \mathcal{C}(I)$ and a partition of the closed interval $I = [t_0, t_N]$, $\Delta : t_0 < t_1 < \dots < t_N$. Let b be defined as before and let $s = (s_1, \dots, s_N)$ be the scaling vector of the IFS defined by (2.11) and (2.21).

The corresponding FIF $g_{\Delta b}^s$, g_b^s , g_Δ^s or simply g^s is called s -fractal function of g with respect to the partition Δ and the function b .

THEOREM 2.4 (see [11]). *The s -fractal function g_b^s of g with respect to Δ and b satisfies the inequality*

$$\|g_b^s - g\|_\infty \leq \frac{|s|_\infty}{1 - |s|_\infty} \|g - b\|_\infty, \tag{2.24}$$

where $|s|_\infty = \max_{1 \leq n \leq N} \{|s_n|\}$. Besides, g_b^s interpolates to g , that is to say,

$$g_b^s(t_n) = g(t_n) \quad \forall n = 0, 1, \dots, N. \tag{2.25}$$

Consequence 2.5. If $s = 0$, then $g_b^s = g$.

Remark 2.6. By (2.7), for all $t \in I_n$, $n = 1, 2, \dots, N$,

$$g_b^s(t) = g(t) + s_n(g_b^s - b) \circ L_n^{-1}(t). \tag{2.26}$$

The first step is to check which conditions should satisfy $b(t)$ in order to fulfill the hypotheses of the theorem of Barnsley and Harrington.

Let us consider $p \geq 0$, $|s_n| < 1/N^p$, and $q_n(t) \in \mathcal{C}^p[t_0, t_N]$, $n = 1, 2, \dots, N$.

The prescribed conditions are

$$F_{n-1,k}(t_N, x_{N,k}) = F_{nk}(t_0, x_{0,k}), \tag{2.27}$$

where $n = 2, 3, \dots, N$, $k = 1, 2, \dots, p$.

We have from the assumptions (2.15) of the theorem,

$$F_{nk}(t, x) = \frac{s_n x + q_n^{(k)}(t)}{a_n^k}. \tag{2.28}$$

In this particular case,

$$q_n(t) = g \circ L_n(t) - s_n b(t) \tag{2.29}$$

as $L_n(t) = (1/N)t + b_n$ and $L'_n(t) = 1/N = a_n$, we have for all $k = 0, 1, \dots, p$,

$$q_n^{(k)}(t) = \frac{1}{N^k} g^{(k)}(L_n(t)) - s_n b^{(k)}(t) \tag{2.30}$$

so that (2.27) becomes

$$\begin{aligned} & N^k s_{n-1} \frac{g^{(k)}(t_N) - N^k s_N b^{(k)}(t_N)}{1 - N^k s_N} - s_{n-1} N^k b^{(k)}(t_N) \\ &= N^k s_n \frac{g^{(k)}(t_0) - N^k s_1 b^{(k)}(t_0)}{1 - N^k s_1} - s_n N^k b^{(k)}(t_0). \end{aligned} \quad (2.31)$$

If we consider constant scale factors $s_n = s_1$ for all $n = 1, \dots, N$,

$$g^{(k)}(t_N) - b^{(k)}(t_N) = g^{(k)}(t_0) - b^{(k)}(t_0). \quad (2.32)$$

A sufficient condition in order to satisfy this equality is

$$\begin{aligned} b^{(k)}(t_0) &= g^{(k)}(t_0), \\ b^{(k)}(t_N) &= g^{(k)}(t_N) \end{aligned} \quad (2.33)$$

for $k = 0, 1, 2, \dots, p$. In this case, we look for a function b which agrees with g at the extremes of the interval until the p th derivative.

The conditions (2.33) will be satisfied if a Hermite interpolating polynomial b is considered, with nodes t_0, t_N and p derivatives at the extremes. In this case, (see [14]),

$$b(t) = H_g(t) = \sum_{k=0}^p g^{(k)}(t_0) \mathcal{L}_{0k}(t) + \sum_{k=0}^p g^{(k)}(t_N) \mathcal{L}_{Nk}(t). \quad (2.34)$$

The functions \mathcal{L}_{ik} are defined by means of intermediate l_{ik} , for $i = 0, N$ and $0 \leq k \leq p$,

$$l_{0k}(t) = \frac{(t - t_0)^k}{k!} \left(\frac{t - t_N}{t_0 - t_N} \right)^{p+1}, \quad l_{Nk}(t) = \frac{(t - t_N)^k}{k!} \left(\frac{t - t_0}{t_N - t_0} \right)^{p+1} \quad (2.35)$$

so that

$$\begin{aligned} \mathcal{L}_{0p}(t) &= l_{0p}(t), \\ \mathcal{L}_{Np}(t) &= l_{Np}(t), \end{aligned} \quad (2.36)$$

and for $k = p - 1, p - 2, \dots, 0$,

$$\begin{aligned} \mathcal{L}_{0k}(t) &= l_{0k}(t) - \sum_{\nu=k+1}^p l_{0k}^{(\nu)}(t_0) \mathcal{L}_{0\nu}(t), \\ \mathcal{L}_{Nk}(t) &= l_{Nk}(t) - \sum_{\nu=k+1}^p l_{Nk}^{(\nu)}(t_N) \mathcal{L}_{N\nu}(t). \end{aligned} \quad (2.37)$$

The mappings \mathcal{L}_{ik} satisfy

$$\mathcal{L}_{ik}^{(\sigma)}(t_j) = \begin{cases} 1 & \text{if } i = j, k = \sigma, \\ 0 & \text{otherwise.} \end{cases} \quad (2.38)$$

The degree of $H_g(t)$ is $2p + 1$. The function g is an interpolant of the data such that $g \in \mathcal{C}^p$.

According to the theorem of Barnsley and Harrington, the IFS associated with the k th derivative of a FIF is expressed by

$$\begin{aligned} L_n(t) &= \frac{1}{N}t + b_n, \\ F_{nk}(t, x) &= N^k s_1 x + N^k q_n^{(k)}(t), \quad k = 0, 1, 2, \dots, p. \end{aligned} \quad (2.39)$$

In our case,

$$q_n(t) = g \circ L_n(t) - s_1 b(t), \quad (2.40)$$

where $b(t)$ is a Hermite interpolating polynomial of degree $2p + 1$ of g . The derivatives of $q_n(t)$ become

$$q_n^{(k)}(t) = \frac{1}{N^k} \mathcal{G}^{(k)}(L_n(t)) - s_1 b^{(k)}(t), \quad k = 0, 1, 2, \dots, p, \quad (2.41)$$

so that the IFS defining the k th derivative of g_b^s is (2.15),

$$\begin{aligned} L_n(t) &= \frac{1}{N}t + b_n, \\ F_{nk}(t, x) &= N^k s_1 x + g^{(k)} \circ L_n(t) - N^k s_1 b^{(k)}(t), \quad k = 0, 1, 2, \dots, p, \end{aligned} \quad (2.42)$$

that is to say, the map q_{nk} corresponding to F_{nk} is

$$q_{nk}(t) = g^{(k)} \circ L_n(t) - N^k s_1 b^{(k)}(t), \quad k = 0, 1, 2, \dots, p, \quad (2.43)$$

so that the k th derivative of the s -fractal function of g with respect to s and b , g_b^s , agrees with the fractal function of $g^{(k)}$ with respect to the scaling vector $N^k s$ and $b^{(k)}$ (Definition 2.3):

$$(g_b^s)^{(k)} = (g^{(k)})_{b^{(k)}}^{N^k s}, \quad k = 0, 1, 2, \dots, p. \quad (2.44)$$

PROPOSITION 2.7. $(g_b^s)^{(k)}$ interpolates to $g^{(k)}$ at the nodes of Δ , for $0 \leq k \leq p$.

Proof. The ordinates of $(g_b^s)^{(k)}$ at the extremes of the interval are given in the theorem of Barnsley and Harrington. Applying (2.16), (2.33), and (2.41),

$$\begin{aligned} (g_b^s)^{(k)}(t_0) &= x_{0,k} = \frac{q_1^{(k)}(t_0)}{a_1^k - s_1} = \frac{1}{a_1^k - s_1} \left(\frac{1}{N^k} \mathcal{G}^{(k)}(L_1(t_0)) - s_1 b^{(k)}(t_0) \right) \\ &= \frac{1}{1 - s_1 N^k} (g^{(k)}(t_0) - s_1 N^k b^{(k)}(t_0)) = g^{(k)}(t_0). \end{aligned} \quad (2.45)$$

In the same way,

$$(g_b^s)^{(k)}(t_N) = g^{(k)}(t_N). \quad (2.46)$$

Now, applying the fixed point equation (2.26) corresponding to k th IFS at t_n ,

$$\begin{aligned} (g_b^s)^{(k)}(t_n) &= F_{nk}(L_n^{-1}(t_n), (g_b^s)^{(k)} \circ L_n^{-1}(t_n)) \\ &= N^k s_1 (g_b^s)^{(k)} \circ L_n^{-1}(t_n) + g^{(k)}(t_n) - N^k s_1 b^{(k)} \circ L_n^{-1}(t_n) = g^{(k)}(t_n) \end{aligned} \quad (2.47)$$

since

$$\begin{aligned} L_n^{-1}(t_n) &= t_N, \\ (g_b^s)^{(k)}(t_N) &= g^{(k)}(t_N) = b^{(k)}(t_N). \end{aligned} \quad (2.48) \quad \square$$

The properties of g_b^s are as the following.

- (i) $(g_b^s)^{(k)}$ interpolates to $g^{(k)}$ at the nodes of the partition Δ , for $0 \leq k \leq p$.
- (ii) g_b^s may be close to g (choosing suitably the scale vector according to (2.24)).
- (iii) g_b^s preserves the p -smoothness of g .
- (iv) g_b^s preserves the boundary conditions of g .
- (v) If $s = 0$, $g_b^s = g$, that is to say, g is a particular case of g_b^s .

Note. Despite the similarity between g_b^s and g , in general, they do not agree. In fact, if $s \neq 0$ and $b \neq g$, then $g_b^s \neq g$.

Let us assume that $g_b^s = g$. If $s_1 \neq 0$, applying (2.26) for $L_n(t) \in I_n$,

$$\begin{aligned} g \circ L_n(t) &= g \circ L_n(t) + s_1(g - b)(t), \\ g(t) &= b(t) \end{aligned} \quad (2.49)$$

for all $t \in I$.

2.3. Uniform bounds. In order to bound the distance between g and g_b^s , we consider a theorem of Ciarlet et al. concerning Hermite interpolation.

Given a partition $\Delta : t_0 < t_1 < \dots < t_N$ of an interval $[t_0, t_N]$, $I_n = [t_{n-1}, t_n]$ for $1 \leq n \leq N$, the Hermite function space (see [14]) H_Δ^{p+1} ($p \in \mathbb{N}$) is defined by

$$H_\Delta^{p+1} = \{\varphi : [t_0, t_N] \rightarrow \mathbb{R}; \varphi \in \mathcal{C}^p[t_0, t_N], \varphi|_{I_n} \in \mathcal{P}_{2p+1}\}, \quad (2.50)$$

where \mathcal{P}_{2p+1} is the space consisting of all polynomials of degree at most $2p + 1$.

THEOREM 2.8 (Ciarlet et al. [6]). *Let $g \in \mathcal{C}^r[t_0, t_N]$ with $r \geq 2p + 2$, let Δ be any partition of $[t_0, t_N]$, let $\Delta : t_0 < t_1 < \dots < t_N$, and let $\varphi(t)$ be the unique interpolation of $g(t)$ in H_Δ^{p+1} , that is, $g^{(l)}(t_n) = \varphi^{(l)}(t_n)$, for all $0 \leq n \leq N$, $0 \leq l \leq p$. Then*

$$\|g^{(k)} - \varphi^{(k)}\|_\infty \leq \frac{\|\Delta\|^{2p+2-k}}{2^{2p+2-2k} k! (2p+2-2k)!} \|g^{(2p+2)}\|_\infty \quad (2.51)$$

for all $k = 0, 1, \dots, p + 1$.

In the case in study, we consider a single subinterval of length $T = b - a$. To bound the difference between the k th derivative of g and the k th derivative of g_b^s , we can use

Theorem 2.4,

$$\|(\mathfrak{g}_b^s)^{(k)} - \mathfrak{g}^{(k)}\|_\infty = \|(\mathfrak{g}^{(k)})_{b^{(k)}}^{N^k s} - \mathfrak{g}^{(k)}\|_\infty \leq \frac{N^k |s_1|}{1 - N^k |s_1|} \|\mathfrak{g}^{(k)} - b^{(k)}\|_\infty. \quad (2.52)$$

Considering that $b(t) = \varphi(t)$ is the Hermite interpolating polynomial of degree $2p + 1$ of g , theorem of Ciarlet et al. can be used in order to bound $\|\mathfrak{g}^{(k)} - b^{(k)}\|_\infty$, so that applying (2.51), (2.52) and considering $g \in \mathcal{C}^{(2p+2)}$,

$$\begin{aligned} \|(\mathfrak{g}_b^s)^{(k)} - \mathfrak{g}^{(k)}\|_\infty &\leq \frac{N^k |s_1|}{1 - N^k |s_1|} \|\mathfrak{g}^{(k)} - b^{(k)}\|_\infty \\ &\leq \frac{N^k |s_1|}{1 - N^k |s_1|} \frac{T^{2p+2-k}}{2^{2p+2-2k} k! (2p+2-2k)!} \|\mathfrak{g}^{(2p+2)}\|_\infty, \quad k = 0, 1, \dots, p. \end{aligned} \quad (2.53)$$

2.4. An operator of $\mathcal{C}^p(I)$. From here on, we denote by g^s the s -fractal function of $g \in \mathcal{C}^p(I)$ with respect to a fixed partition Δ of the interval, a scaling vector s with constant coordinates $s_n = s_1$ for all $n = 1, 2, \dots, N$ and $b(t) = H_g(t)$ defined in the preceding sections.

For fixed Δ , let us consider the operator of $\mathcal{C}^p(I)$ which assigns g^s to the function g ,

$$\mathfrak{D}_p^s(g) = g^s. \quad (2.54)$$

THEOREM 2.9. \mathfrak{D}_p^s is a linear, injective, and bounded operator of $\mathcal{C}^p(I)$.

Proof. The operator is linear as by (2.26) for all $t \in I_n$,

$$\begin{aligned} f^s(t) &= f(t) + s_n(f^s - H_f) \circ L_n^{-1}(t), \\ g^s(t) &= g(t) + s_n(g^s - H_g) \circ L_n^{-1}(t). \end{aligned} \quad (2.55)$$

Multiplying the first equation by λ and the second by μ and considering that

$$\lambda H_f + \mu H_g = H_{\lambda f + \mu g}, \quad (2.56)$$

the function

$$\lambda f^s + \mu g^s \quad (2.57)$$

satisfies the equation corresponding to

$$(\lambda f + \mu g)^s. \quad (2.58)$$

By the uniqueness of the solution, the linearity is proved.

To prove the injectivity, let us consider that $g^s = 0$. In this case, for all $t \in I_n$ by (2.26),

$$0 = g(t) - s_1 H_g \circ L_n^{-1}(t) \quad (2.59)$$

but this equation is satisfied by $g(t) = 0$ and due to the uniqueness of the solution $g = 0$.

We consider $\mathcal{C}^p(I)$ endowed with the norm $\|f\|_{\mathcal{C}^p(I)} = \sum_{k=0}^p \|f^{(k)}\|_{\infty}$. Using the definition of $H_g(t)$ (2.34),

$$\begin{aligned} \|H_g^{(j)}(t)\|_{\infty} &= \sup \left| \sum_{k=0}^p \left(g^{(k)}(t_0) \mathcal{L}_{0k}^{(j)}(t) + g^{(k)}(t_N) \mathcal{L}_{Nk}^{(j)}(t) \right) \right|, \\ \|H_g^{(j)}(t)\|_{\infty} &\leq \sup_{t \in I} \|g\|_{\mathcal{C}^p(I)} \sum_{k=0}^p \left(\left| \mathcal{L}_{0k}^{(j)}(t) \right| + \left| \mathcal{L}_{Nk}^{(j)}(t) \right| \right). \end{aligned} \quad (2.60)$$

Let us consider

$$\lambda_p = \sup_{\substack{t \in I \\ 0 \leq j \leq p}} \sum_{k=0}^p \left(\left| \mathcal{L}_{0k}^{(j)}(t) \right| + \left| \mathcal{L}_{Nk}^{(j)}(t) \right| \right) \quad (2.61)$$

then

$$\begin{aligned} \|H_g\|_{\mathcal{C}^p(I)} &\leq \|g\|_{\mathcal{C}^p(I)} \lambda_p, \\ \|g - H_g\|_{\mathcal{C}^p(I)} &\leq (\lambda_p + 1) \|g\|_{\mathcal{C}^p(I)}. \end{aligned} \quad (2.62)$$

On the other hand, using Theorem 2.4, (2.52), and

$$\frac{N^j |s_1|}{1 - N^j |s_1|} \leq \frac{N^p |s_1|}{1 - N^p |s_1|} \quad (2.63)$$

for $0 \leq j \leq p$, one has

$$\|g^s - g\|_{\mathcal{C}^p(I)} \leq \frac{N^p |s_1|}{1 - N^p |s_1|} \|g - H_g\|_{\mathcal{C}^p(I)}, \quad (2.64)$$

by (2.64) and (2.62),

$$\begin{aligned} \|g^s\|_{\mathcal{C}^p(I)} - \|g\|_{\mathcal{C}^p(I)} &\leq \frac{N^p |s_1|}{1 - N^p |s_1|} (\lambda_p + 1) \|g\|_{\mathcal{C}^p(I)}, \\ \|g^s\|_{\mathcal{C}^p(I)} &\leq \frac{1 + \lambda_p N^p |s_1|}{1 - N^p |s_1|} \|g\|_{\mathcal{C}^p(I)}. \end{aligned} \quad (2.65)$$

As a consequence, \mathcal{D}_p^s is bounded and

$$\|\mathcal{D}_p^s\| \leq \frac{1 + \lambda_p N^p |s_1|}{1 - N^p |s_1|}. \quad (2.66)$$

□

2.5. Convergence in $\mathcal{C}^p(I)$. Let $x \in \mathcal{C}^p(I)$ be an original function providing the data and let $g_{\Delta_N} \in \mathcal{C}^p(I)$ be an interpolant of x on the partition Δ_N . We consider the fractal function $g_{\Delta_N}^{s^N}$ of g_{Δ_N} with respect to the partition Δ_N , the scale vector s^N with constant coordinates, and the function b defined by the equality (2.34).

THEOREM 2.10. *If $x \in \mathcal{C}^p(I)$ is an original function and g_{Δ_N} is a p -smooth interpolant of x with respect to the partition Δ_N , consider a scaling vector s^N with constant coordinates such that $|s_1^N| < 1/N^p$, then*

$$\|x - g_{\Delta_N}^{s^N}\|_{\mathcal{C}^p(I)} \leq \|x - g_{\Delta_N}\|_{\mathcal{C}^p(I)} + \frac{N^p |s_1^N|}{1 - N^p |s_1^N|} (\lambda_p + 1) \|g_{\Delta_N}\|_{\mathcal{C}^p(I)}. \quad (2.67)$$

Proof. One has

$$\|x - g_{\Delta_N}^{s^N}\|_{\mathcal{C}^p(I)} \leq \|x - g_{\Delta_N}\|_{\mathcal{C}^p(I)} + \|g_{\Delta_N} - g_{\Delta_N}^{s^N}\|_{\mathcal{C}^p(I)}, \quad (2.68)$$

by (2.64),

$$\|x - g_{\Delta_N}^{s^N}\|_{\mathcal{C}^p(I)} \leq \|x - g_{\Delta_N}\|_{\mathcal{C}^p(I)} + \frac{N^p |s_1^N|}{1 - N^p |s_1^N|} \|g_{\Delta_N} - H_{g_{\Delta_N}}\|_{\mathcal{C}^p(I)}. \quad (2.69)$$

Using (2.62), the result is obtained. \square

Consequence 2.11. If one considers a scaling vector such that $|s_1^N| < 1/N^{p+r}$, for $r > 0$ fixed, the fractal interpolant $g_{\Delta_N}^{s^N}$ converges in $\mathcal{C}^p(I)$ towards the original x if g_{Δ_N} does (as N tends to ∞).

Note. The constant λ_p does not depend on Δ_N but only on the extremes of the interval.

3. Fractal cubic splines

In this section, we study the particular case $p = 2$, considering the following IFS:

$$\begin{aligned} L_n(t) &= a_n t + b_n, \\ F_n(t, x) &= s_n x + q_n(t), \end{aligned} \quad (3.1)$$

where $a_n = 1/N$, $s_n = s_1$ for all $n = 1, 2, \dots, N$,

$$q_n(t) = g \circ L_n(t) - s_1 b(t), \quad (3.2)$$

where g is a cubic spline with respect to a uniform partition Δ_N ($g = \sigma_{\Delta_N}$) and $b = H_g$ is a Hermite interpolating polynomial satisfying the described conditions (2.33) with $p = 2$ ($b(t)$ is a polynomial of degree 5).

We use a classical result of splines in order to find $\mathcal{C}^2(I)$ bounds of the interpolation error.

THEOREM 3.1 (Hall and Meyer [7]). *Let $f \in \mathcal{C}^4[a, b]$ and $|f^{(4)}(t)| \leq L$ for all $t \in [a, b]$. Let $\|f\|_\infty = \sup |f(t)|$ when $t \in [a, b]$. Let $\Delta_N = \{a = t_0 < t_1 < \dots < t_N = b\}$ be a partition of the interval $[a, b]$, with constant distances between nodes $h = t_n - t_{n-1}$. Let σ_{Δ_N} be the spline function that interpolates the values of the function f at the points $t_0, t_1, \dots, t_N \in \Delta_N$, being σ_{Δ_N} type I or II. Then*

$$\|f^{(r)} - \sigma_{\Delta_N}^{(r)}\|_\infty \leq C_r L h^{4-r} \quad (r = 0, 1, 2) \quad (3.3)$$

with $C_0 = 5/384$, $C_1 = 1/24$, $C_2 = 3/8$. The constants C_0 and C_1 are optimum.

Remark 3.2. A spline is type I if its first derivatives at a and b are known. A spline is type II if it can be explicitly represented by its second derivatives at a and b .

THEOREM 3.3. *Let $x(t)$ be a function verifying $x(t) \in \mathcal{C}^4[t_0, t_N]$ and $|x^{(4)}(t)| \leq L$ for all $t \in [t_0, t_N]$. Let $\sigma_{\Delta_N}(t)$ be a cubic spline (with respect to the uniform partition Δ_N) and let $b(t)$ be a Hermite interpolating polynomial of degree 5 of σ_{Δ_N} at the extremes of the interval. Choose a scaling vector with constant coordinates such that $|s_1^N| < 1/N^2$, then*

$$\|x - \sigma_{\Delta_N}^{s^N}\|_{\mathcal{C}^2(I)} \leq M_h + \frac{N^2 |s_1^N|}{1 - N^2 |s_1^N|} (\lambda_2 + 1) (M_h + \|x\|_{\mathcal{C}^2(I)}), \quad (3.4)$$

where $M_h = C_0 L h^4 + C_1 L h^3 + C_2 L h^2$, C_0, C_1, C_2 are the constants of Hall and Meyer theorem, $T = t_N - t_0 = Nh$, and λ_2 is defined in (2.61).

Proof. Applying Theorem 2.10,

$$\|x - \sigma_{\Delta_N}^{s^N}\|_{\mathcal{C}^2(I)} \leq M_h + \frac{N^2 |s_1^N|}{1 - N^2 |s_1^N|} (\lambda_2 + 1) \|\sigma_{\Delta_N}\|_{\mathcal{C}^2(I)}. \quad (3.5)$$

Using now theorem of Hall and Meyer,

$$\|\sigma_{\Delta_N}\|_{\mathcal{C}^2(I)} \leq M_h + \|x\|_{\mathcal{C}^2(I)} \quad (3.6)$$

and the result is obtained. \square

3.1. Convergence in $\mathcal{H}^2[a, b]$. In this subsection, we weaken the hypotheses about the original function x . The set

$$\mathcal{H}^2[a, b] = \{x : [a, b] \rightarrow \mathbb{R}; x' \text{ absolutely continuous}; x'' \in L^2(a, b)\} \quad (3.7)$$

is a Hilbert space with respect to the inner product

$$\langle x, y \rangle = \sum_{j=0}^2 \langle x^{(j)}, y^{(j)} \rangle_{L^2(a, b)}, \quad (3.8)$$

where

$$\langle f, g \rangle_{L^2(a, b)} = \left(\int_a^b f(t)g(t)dt \right)^{1/2} \quad (3.9)$$

and the norm

$$\|x\|_{\mathcal{H}^2[a, b]} = \left(\sum_{j=0}^2 \|x\|_j^2 \right)^{1/2}, \quad (3.10)$$

where

$$\|x\|_j = \left(\int_a^b (x^{(j)}(t))^2 dt \right)^{1/2} = \|x^{(j)}\|_{L^2(a, b)} \quad \text{for } j = 0, 1, 2. \quad (3.11)$$

Cubic splines belong to $\mathcal{H}^2[a, b]$ and these functions satisfy the following very well-known properties with respect to the elements of $\mathcal{H}^2[a, b]$ (see [1]).

THEOREM 3.4. *Consider $x \in \mathcal{H}^2[a, b]$ and consider a sequence of partitions Δ_N such that $\|\Delta_N\| \rightarrow 0$ as $N \rightarrow \infty$. If σ_{Δ_N} is a spline of interpolation of x with respect to the partition Δ_N , then $\{\sigma_{\Delta_N}^{(q)}\}$ converges uniformly to $x^{(q)}$ on $I = [a, b]$ for $q = 0, 1$.*

THEOREM 3.5. *If $x \in \mathcal{H}^2[a, b]$ and σ_Δ is a spline of interpolation of x with respect to the partition Δ , then*

$$\|x\|_2^2 = \|\sigma_\Delta\|_2^2 + \|x - \sigma_\Delta\|_2^2. \tag{3.12}$$

Consequence 3.6. One has

$$\|x\|_2^2 - \|\sigma_\Delta\|_2^2 \geq 0. \tag{3.13}$$

Consequence 3.7. If $x \in \mathcal{H}^2[a, b]$ is such that $x(t_i) = x_i$ at the nodes of the partition Δ and $\sigma_\Delta(t)$ is the cubic spline corresponding to (t_i, x_i) , then

$$\int_a^b |\sigma_\Delta''(t)|^2 dt \leq \int_a^b |x''(t)|^2 dt \tag{3.14}$$

(property of minimum $\|\cdot\|_2$ -norm).

Theorem 3.9 states the convergence of fractal cubic splines towards the original function if an additional condition is imposed on the scaling factors. We need a previous result concerning fractal interpolation functions.

LEMMA 3.8. *For a uniform partition and constant scale factors $s_n = s_1$, for all $n = 1, \dots, N$,*

$$\|f^s - f\|_{L^2(a,b)} \leq \frac{|s_1|}{1 - |s_1|} \|f - b\|_{L^2(a,b)}. \tag{3.15}$$

Proof. According to (2.26), for all $t \in I_n$,

$$\begin{aligned} f^s(t) - f(t) &= s_1(f^s - b) \circ L_n^{-1}(t), \\ \|f^s - f\|_{L^2(a,b)}^2 &= \sum_{n=1}^N s_1^2 \int_{t_{n-1}}^{t_n} [(f^s - b) \circ L_n^{-1}(t)]^2 dt. \end{aligned} \tag{3.16}$$

The change of variable $\tilde{t} = L_n^{-1}(t)$ provides

$$\begin{aligned} \|f^s - f\|_{L^2(a,b)}^2 &= s_1^2 \sum_{n=1}^N a_n \int_a^b [(f^s - b)(\tilde{t})]^2 d\tilde{t}, \\ \|f^s - f\|_{L^2(a,b)}^2 &= s_1^2 \|f^s - b\|_{L^2(a,b)}^2. \end{aligned} \tag{3.17}$$

As a consequence,

$$\begin{aligned} \|f^s - f\|_{L^2(a,b)} &= |s_1| \|f^s - b\|_{L^2(a,b)} \leq |s_1| (\|f^s - f\|_{L^2(a,b)} + \|f - b\|_{L^2(a,b)}), \\ \|f^s - f\|_{L^2(a,b)} &\leq \frac{|s_1|}{1 - |s_1|} \|f - b\|_{L^2(a,b)}. \end{aligned} \quad (3.18)$$

□

The next theorem states the convergence of fractal cubic splines towards any original function $x \in \mathcal{H}^2[a, b]$ when the partition is refined. A part of the proof can be read in [1, Theorem 3.14.1]. For reason of completeness, we include it here.

THEOREM 3.9. *Consider $x \in \mathcal{H}^2[a, b]$ and let $\{\Delta_N\}$ be a sequence of partitions such that $\Delta_N \subseteq \Delta_{N+1}$ and $\|\Delta_N\| \rightarrow 0$ as $N \rightarrow \infty$. Let $s^N \in (-1, 1)^N$ be any sequence of scaling vectors with constant coordinates satisfying $|s_1^N| < 1/N^{2+r}$, where $r > 0$, then $\{\sigma_{\Delta_N}^{s^N}\}$ converges to x in the norm of $\mathcal{H}^2[a, b]$.*

Proof. As $\Delta_N \subseteq \Delta_{N+1}$, the spline σ_{Δ_N} interpolates to $\sigma_{\Delta_{N+1}}$ at the nodes of Δ_N . Applying the property of minimum $\|\cdot\|_2$ -norm,

$$\|\sigma_{\Delta_N}\|_2 \leq \|\sigma_{\Delta_{N+1}}\|_2. \quad (3.19)$$

As a consequence, $\{\|\sigma_{\Delta_N}\|_2\}_{N=1}^\infty$ is increasing. Besides, σ_{Δ_N} is bounded because of (3.13),

$$\|\sigma_{\Delta_N}\|_2 \leq \|x\|_2, \quad (3.20)$$

therefore, $\{\|\sigma_{\Delta_N}\|_2\}_{N=1}^\infty$ is a convergent sequence. Using the same argument, as $\Delta_N \subseteq \Delta_{N+p}$ for all $p \in N$, by (3.12),

$$\|\sigma_{\Delta_{N+p}} - \sigma_{\Delta_N}\|_2^2 = \|\sigma_{\Delta_{N+p}}\|_2^2 - \|\sigma_{\Delta_N}\|_2^2 \quad (3.21)$$

and $\{\sigma_{\Delta_N}''\}$ is a Cauchy sequence in $L^2(a, b)$. As $L^2(a, b)$ is complete, there exists $y \in L^2(a, b)$ such that

$$\lim_{N \rightarrow \infty} \int_a^b |y(t) - \sigma_{\Delta_N}''(t)|^2 dt = 0. \quad (3.22)$$

Let us define $Y(t) = x'(a) + \int_a^t y(u) du$,

$$\begin{aligned} |Y(t) - \sigma_{\Delta_N}'(t)| &\leq \int_a^t |y(u) - \sigma_{\Delta_N}''(u)| du + |x'(a) - \sigma_{\Delta_N}'(a)| \\ &\leq \langle |y - \sigma_{\Delta_N}''|, 1 \rangle_{L^2(a,b)} + |x'(a) - \sigma_{\Delta_N}'(a)|. \end{aligned} \quad (3.23)$$

Using Schwarz's inequality,

$$|Y(t) - \sigma_{\Delta_N}'(t)| \leq \left(\int_a^b |y(t) - \sigma_{\Delta_N}''(t)|^2 dt \right)^{1/2} (b-a)^{1/2} + |x'(a) - \sigma_{\Delta_N}'(a)|. \quad (3.24)$$

Considering (3.22), (3.24), and Theorem 3.4,

$$\lim_{N \rightarrow \infty} \sigma_{\Delta_N}'(t) \stackrel{\text{unif}}{=} Y(t). \quad (3.25)$$

Besides,

$$|x'(t) - Y(t)| \leq |x'(t) - \sigma'_{\Delta_N}(t)| + |\sigma'_{\Delta_N}(t) - Y(t)|. \quad (3.26)$$

Applying limits in this expression as $N \rightarrow \infty$, according to Theorem 3.4 and (3.25), $x' = Y$ and $x'' = Y' = y$ almost everywhere. As a consequence by (3.22), as $N \rightarrow \infty$,

$$\|\sigma_{\Delta_N} - x\|_2 \rightarrow 0 \quad (3.27)$$

and by (3.25),

$$\|\sigma'_{\Delta_N} - x'\|_\infty \rightarrow 0. \quad (3.28)$$

According to Theorem 3.4, as $\|\Delta_N\| \rightarrow 0$ and $x \in \mathcal{H}^2(a, b)$,

$$\|\sigma_{\Delta_N} - x\|_\infty \rightarrow 0. \quad (3.29)$$

The uniform convergence on $I = [a, b]$ implies L^2 -convergence and

$$\|\sigma_{\Delta_N} - x\|_{\mathcal{H}^2[a, b]} \rightarrow 0. \quad (3.30)$$

Let us consider now any sequence of scaling factors such that $|s_1^N| < 1/N^{2+r}$, where $r > 0$. One has

$$\|x - \sigma_{\Delta_N}^{s^N}\|_{\mathcal{H}^2[a, b]} \leq \|x - \sigma_{\Delta_N}\|_{\mathcal{H}^2[a, b]} + \|\sigma_{\Delta_N}^{s^N} - \sigma_{\Delta_N}\|_{\mathcal{H}^2[a, b]}. \quad (3.31)$$

Considering (2.44) and Lemma 3.8, for $j = 0, 1, 2$,

$$\left\| (\sigma_{\Delta_N}^{s^N})^{(j)} - \sigma_{\Delta_N}^{(j)} \right\|_{L^2(a, b)} \leq \frac{N^j |s_1^N|}{1 - N^j |s_1^N|} \left\| \sigma_{\Delta_N}^{(j)} - b^{(j)} \right\|_{L^2(a, b)}. \quad (3.32)$$

As a consequence, bearing in mind that for $j = 0, 1, 2$,

$$\frac{N^j |s_1^N|}{1 - N^j |s_1^N|} \leq \frac{N^2 |s_1^N|}{1 - N^2 |s_1^N|}, \quad (3.33)$$

one has

$$\|\sigma_{\Delta_N}^{s^N} - \sigma_{\Delta_N}\|_{\mathcal{H}^2[a, b]} \leq \frac{N^2 |s_1^N|}{1 - N^2 |s_1^N|} \|\sigma_{\Delta_N} - b\|_{\mathcal{H}^2[a, b]} \quad (3.34)$$

on the other hand,

$$\|\sigma_{\Delta_N} - b\|_{\mathcal{H}^2[a, b]} \leq \|\sigma_{\Delta_N} - x\|_{\mathcal{H}^2[a, b]} + \|x - b\|_{\mathcal{H}^2[a, b]}. \quad (3.35)$$

Due to the convergence of σ_{Δ_N} to x in $\mathcal{H}^2[a, b]$ (3.30), $\|\sigma_{\Delta_N} - b\|_{\mathcal{H}^2[a, b]}$ is bounded (3.35).

Since $|s_1^N| < 1/N^{2+r}$, taking limits in (3.34) as $N \rightarrow \infty$,

$$\|\sigma_{\Delta_N}^{s^N} - \sigma_{\Delta_N}\|_{\mathcal{H}^2[a,b]} \rightarrow 0. \quad (3.36)$$

Finally, by (3.30) and (3.31),

$$\sigma_{\Delta_N}^{s^N} \rightarrow x \quad (3.37)$$

in $\mathcal{H}^2[a, b]$. □

Consequence 3.10. The fractal cubic splines with non-null scale vector are dense in $\mathcal{H}^2[a, b]$.

Note. For $s^N = 0$, we retrieve the standard spline case.

3.2. Fractal cubic spline operator. Let

$$\Delta_N : a = t_0 < t_1 < t_2 < \dots < t_{N+1} = b \quad (3.38)$$

be a given partition of the interval $[a, b]$. We follow here the spline definition of Laurent (see [9]). In order to simplify the notation, we will omit the subindex and we will write $\sigma(t)$ to represent a spline with respect to Δ_N .

Definition 3.11. Let S be the space of cubic spline functions σ defined in $[a, b]$ such that

- (i) σ is a cubic polynomial on each subinterval (t_k, t_{k+1}) , $k = 1, \dots, N-1$,
- (ii) σ is a polynomial of degree 1 in $[a, t_1)$ and $(t_N, b]$,
- (iii) σ'' is continuous.

Note 1. S is a linear subspace of $\mathcal{H}^2[a, b]$.

Note 2. In this case, $\sigma''(a) = \sigma''(b) = 0$ (natural splines).

Note 3. Every $\sigma \in S$ can be expressed as (see [9]),

$$\sigma(t) = \sum_{j=0}^1 s_j t^j + \sum_{k=1}^N d_k \frac{(t - t_k)_+^3}{3!}, \quad (3.39)$$

where

$$(t - t_k)_+^3 = \begin{cases} (t - t_k)^3 & \text{if } t \geq t_k, \\ 0 & \text{if } t < t_k, \end{cases} \quad (3.40)$$

$$d_k = \sigma^{(3)}(t_k +) - \sigma^{(3)}(t_k -).$$

Besides, d_k satisfies the condition

$$\sum_{k=1}^N d_k (t_k)^K = 0, \quad K = 0, 1. \quad (3.41)$$

Let σ_{kN} be the unique cubic spline defined by

$$\sigma_{kN}(t_j) = \delta_{jk} \quad \forall j, k = 1, 2, \dots, N, \quad (3.42)$$

where δ_{jk} is the delta of Kronecker. The family $\{\sigma_{kN}\}_{k=1}^N$ is an orthonormal system with respect to the form

$$\langle f, g \rangle = \sum_{k=1}^N f(t_k)g(t_k). \quad (3.43)$$

Besides,

$$S = \text{span} \{\sigma_{kN}\}_{k=1}^N. \quad (3.44)$$

Let s be a scale vector with constant coordinates such that $|s_1| < 1/(N+1)^2$. As $S \subset \mathcal{C}^2(I)$, we can consider the operator \mathcal{D}_p^s defined in Section 2.4 for $p = 2$. $\mathcal{D}_2^s(S) = S^s$ is the space of s -fractal functions of S with respect to the partition

$$\Delta_N : a = t_0 < t_1 < t_2 < \dots < t_{N+1} = b. \quad (3.45)$$

Since \mathcal{D}_2^s is linear,

$$\mathcal{D}_2^s(S) = S^s = \text{span} \{\sigma_{kN}^s\}_{k=1}^N. \quad (3.46)$$

The family σ_{kN}^s is orthonormal respect to (3.43) because

$$\sigma_{kN}^s(t_j) = \sigma_{kN}(t_j) = \delta_{jk} \quad (3.47)$$

for $k, j = 1, 2, \dots, N$. As a consequence, $\{\sigma_{kN}^s\}_{k=1}^N$ is a basis of S^s .

Let us define the fractal cubic spline operator with domain $\mathcal{C}[a, b]$ or, more specifically, $\mathcal{H}^2[a, b]$,

$$\mathcal{P}_N^s(g)(t) = \sum_{k=1}^N g(t_k)\sigma_{kN}^s(t). \quad (3.48)$$

Note that for all $k = 1, 2, \dots, N$,

$$\mathcal{P}_N^s(g)(t_k) = g(t_k) \quad (3.49)$$

since, for all $j, k = 1, 2, \dots, N$,

$$\sigma_{kN}^s(t_j) = \sigma_{kN}(t_j) = \delta_{jk}. \quad (3.50)$$

PROPOSITION 3.12. \mathcal{P}_N^s is linear.

Proof. It is an immediate consequence of (3.48). □

Without loss of generality, we consider $I = [0, 1]$ and $t_k = k/N$.

LEMMA 3.13. Let f and g be defined in I such that $f(t_k) = g(t_k)$ for $k = 1, 2, \dots, N$ for some N , then

$$\mathcal{I}_N^s(f) = \mathcal{I}_N^s(g). \quad (3.51)$$

Proof. For all $t \in I$,

$$\mathcal{I}_N^s(f)(t) = \sum_{k=1}^N f(t_k) \sigma_{kN}^s(t) = \sum_{k=1}^N g(t_k) \sigma_{kN}^s(t) = \mathcal{I}_N^s(g)(t). \quad (3.52)$$

□

Let us consider a sequence of partitions Δ_N such that $\Delta = \bigcup_{N \in \mathbb{N}} \Delta_N$ is dense in I .

LEMMA 3.14. If f and g are functions defined on I such that

$$\lim_{N \rightarrow \infty} \mathcal{I}_N^s(f)(t) = g(t) \quad \forall t \in \Delta, \quad (3.53)$$

then

$$f(t) = g(t) \quad \forall t \in \Delta. \quad (3.54)$$

Proof. If $t \in \Delta$, then $t \in \Delta_{N_0}$ for some N_0 , $t = n/N_0$ and by (3.49),

$$\mathcal{I}_{N_0}^s(f)(t) = f(t). \quad (3.55)$$

If the sequence of partitions $\{\Delta_{mN_0}\}$ is considered $t = n/N_0 = mn/mN_0 \in \Delta_{mN_0}$ and $\mathcal{I}_{mN_0}^s(f)(t) = f(t)$,

$$f(t) = \lim_{m \rightarrow \infty} \mathcal{I}_{mN_0}^s(f)(t) = g(t). \quad (3.56)$$

□

PROPOSITION 3.15. If, in addition to the hypotheses of Lemma 3.14, f and $g \in \mathcal{H}^2[0, 1]$, then $f = g$.

Proof. It is a consequence of the density of Δ in I and the continuity of f and g . If $t \in [a, b]$ there exists $\bar{t}_m \in \Delta$ such that $\bar{t}_m \xrightarrow{m \rightarrow \infty} t$ therefore, $f(\bar{t}_m) \rightarrow f(t)$ and $g(\bar{t}_m) \rightarrow g(t)$ as $m \rightarrow \infty$. But $f(\bar{t}_m) = g(\bar{t}_m)$ (previous lemma) and therefore, $f(t) = g(t)$, for all $t \in I$. □

PROPOSITION 3.16. If $g \in \mathcal{C}^2(I)$, then $\mathcal{I}_N^s(g^s) = \mathcal{I}_N^s(g)$. ($g^s = \mathcal{D}_2^s(g)$ with respect to the partition Δ_N .)

Proof. It is an immediate consequence of the definition of \mathcal{I}_N^s and the properties of interpolation of g^s with respect to g . □

PROPOSITION 3.17. If $\sigma \in S$, then $\mathcal{I}_N^s(\sigma^s) = \sigma^s$.

Proof. Let us consider $\sigma \in S$. By Proposition 3.16, since $\sigma \in \mathcal{C}^2(I)$,

$$\mathcal{I}_N^s(\sigma^s)(t) = \mathcal{I}_N^s(\sigma)(t) = \sum_{k=1}^N \sigma(t_k) \sigma_{kN}^s(t). \quad (3.57)$$

On the other hand,

$$\sigma(t) = \sum_{k=1}^N \sigma(t_k) \sigma_{kN}(t) \tag{3.58}$$

because the spline passing through $\sigma(t_k)$ is unique. By the linearity of \mathcal{D}_2^s ,

$$\sigma^s(t) = \sum_{k=1}^N \sigma(t_k) \sigma_{kN}^s(t), \tag{3.59}$$

by (3.57) and (3.59),

$$\mathcal{F}_N^s(\sigma^s) = \sigma^s. \tag{3.60}$$

□

Consequence 3.18. The fractal cubic splines with scale vector s are eigenfunctions (or fixed points) of the operator \mathcal{F}_N^s .

PROPOSITION 3.19. \mathcal{F}_N^s is a projector of $\mathcal{H}^2[0, 1]$,

$$\mathcal{F}_N^s \circ \mathcal{F}_N^s = \mathcal{F}_N^s. \tag{3.61}$$

Proof. For all $g \in \mathcal{H}^2[0, 1]$,

$$\mathcal{F}_N^s(g) = \sum_{k=1}^N g(t_k) \sigma_{kN}^s \in \mathcal{S}^s \tag{3.62}$$

and, as a consequence, $\mathcal{F}_N^s(g)$ is a fixed point of \mathcal{F}_N^s (Proposition 3.17),

$$\mathcal{F}_N^s(\mathcal{F}_N^s(g)) = \mathcal{F}_N^s(g). \tag{3.63}$$

□
