Existence and Stability of Antiperiodic Solution for a Class of Generalized Neural Networks with Impulses and Arbitrary Delays on Time Scales

By using coincidence degree theory and Lyapunov functions, we study the existence and global exponential stability of antiperiodic solutions for a class of generalized neural networks with impulses and arbitrary delays on time scales. Some completely new sufficient conditions are established. Finally, an example is given to illustrate our results. These results are of great significance in designs and applications of globally stable anti-periodic Cohen-Grossberg neural networks with delays and impulses .

1. Introduction

In this paper, we consider the following generalized neural networks with impulses and arbitrary delays on time scales:

where \mathbb{T} is an $\omega/2$ -periodic time scale and if $t \in \mathbb{T}$, $\theta \in E$, then $t + \theta \in \mathbb{T}$, E is a subset of $R^- = (-\infty, 0]$, $A(t, x(t)) = \operatorname{diag}(a_1(t, x_1(t)), a_2(t, x_2(t)), \ldots, a_n(t, x_n(t)))$, $B(t, x(t)) = (b_1(t, x_1(t)), b_2(t, x_2(t)), \ldots, b_n(t, x_n(t)))^T$, $F(t, x_t) = (f_1(t, x_t), \ldots, f_n(t, x_t))^T$, $f_i(t, x_t) = f_i(t, x_{1t}, x_{2t}, \ldots, x_{nt})$, $x_{it}(\theta) = x_i(t + \theta)$, $t \in \mathbb{T}$, $\theta \in E$, $i = 1, 2, \ldots, n$, and $x(t_k^+), x(t_k^-)$ represent the right and left limits of $x(t_k)$ in the sense of time scales, t_l is a sequence of real numbers such that $t_l < t_l < t_l < \cdots < t_n \to \infty$ as $t_l < \infty$. There exists a positive integer t_l such that $t_l < t_l < t_$

assume that $[0, \omega/2)_{\mathbb{T}} \cap \{t_l : l \in \mathbb{N}\} = \{t_1, t_2, \dots, t_q\}$. For each interval I of \mathbb{R} , we denote that $I_{\mathbb{T}} = I \cap \mathbb{T}$, especially, we denote that $\mathbb{T}^+ = \mathbb{T} \cap [0, +\infty)$.

System (1.1) includes many neural continuous and discrete time networks [1–9]. For examples, the high-order Hopfield neural networks with impulses and delays (see [8]):

the Cohen-Grossberg neural networks with bounded and unbounded delays (see [9]):

Arising from problems in applied sciences, it is well known that anti-periodic problems of nonlinear differential equations have been extensively studied by many authors during the past twenty years; see [10–21] and references cited therein. For example, anti-periodic trigonometric polynomials are important in the study of interpolation problems [22, 23], and anti-periodic wavelets are discussed in [24].

Recently, several authors [25–30] have investigated the anti-periodic problems of neural networks without impulse by similar analytic skills. However, to the best of our knowledge, there are few papers published on the existence of anti-periodic solutions to neural networks with impulse.

The main purpose of this paper is to study the existence and global exponential stability of anti-periodic solutions of system (1.1) by using the method of coincidence degree theory and Lyapunov functions.

The initial conditions associated with system (1.1) are of the form

Throughout this paper, we assume that

 (H_1) $a_i(t,u) \in C(\mathbb{T} \times \mathbb{R}, \mathbb{R}^+)$, $a_i(t+\omega/2, -u) = a_i(t,u)$, and there exist positive constants a_i^m, a_i^M such that $0 < a_i^m < a_i(t,u) < a_i^M$ for all $t \in \mathbb{T}, u \in \mathbb{R}, i = 1,2,\ldots,n$;

 (H_2) $b_i(t,u) \in C(\mathbb{T} \times \mathbb{R}, \mathbb{R}), b_i(t+\omega/2, -u) = -b_i(t,u)$. There exist positive constants μ_i and L_i^b such that

for all $t \in \mathbb{T}$, $u, v \in \mathbb{R}$, i = 1, 2, ..., n;

 (H_3) $f_i \in C(\mathbb{T} \times \mathbb{R}^n, \mathbb{R}), f_i(t + \omega/2, -u) = -f_i(t, u), \text{ for } i = 1, 2, ..., n.$ There exist positive constants c_i such that

for all $(t, x_{1t}, ..., x_{nt}), (t, y_{1t}, ..., y_{nt}) \in \mathbb{T} \times \mathbb{R}^n$ and $f_i(t, 0, ..., 0) = 0, i = 1, 2, ..., n$;

 (H_4) $I_{ik} \in C(\mathbb{R}, \mathbb{R})$ and there exist positive constants L_{ik}^I such that

for all $u, v \in \mathbb{R}$, $k \in \mathbb{N}$, i = 1, 2, ..., n.

For convenience, we introduce the following notation:

$$h^{M} = \max_{t \in [0,\omega]_{\mathbb{T}}} |h(t)|, \qquad h^{m} = \min_{t \in [0,\omega]_{\mathbb{T}}} |h(t)|, \qquad ||h||_{2} = \left(\int_{0}^{\omega} |h(t)|^{2} \Delta t\right)^{1/2}, \tag{1.10}$$

where h is an ω -periodic function.

The organization of this paper is as follows. In Section 2, we introduce some definitions and lemmas. In Section 3, by using the method of coincidence degree theory, we obtain the existence of the anti-periodic solutions of system (1.1). In Section 4, we give the criteria of global exponential stability of the anti-periodic solutions of system (1.1). In Section 5, an example is also provided to illustrate the effectiveness of the main results in Sections 3 and 4. The conclusions are drawn in Section 6.

2. Preliminaries

In this section, we will first recall some basic definitions and lemmas which can be found in books [31, 32].

Definition 2.1 (see [31]). A time scale $\mathbb T$ is an arbitrary nonempty closed subset of real numbers $\mathbb R$. The forward and backward jump operators $\sigma, \rho: \mathbb T \to \mathbb T$ and the graininess $\mu: \mathbb T \to \mathbb R^+$ are defined, respectively, by

$$\sigma(t) := \inf\{s \in \mathbb{T} : s > t\}, \qquad \rho(t) := \sup\{s \in \mathbb{T} : s < t\}, \qquad \mu(t) = \sigma(t) - t. \tag{2.1}$$

Definition 2.2 (see [31]). A function $f: \mathbb{T} \to \mathbb{R}$ is called right-dense continuous provided it is continuous at right-dense point of \mathbb{T} and left-side limit exists (finite) at left-dense point of \mathbb{T} . The set of all right-dense continuous functions on \mathbb{T} will be denoted by $C_{\rm rd} = C_{\rm rd}(\mathbb{T}) = C_{\rm rd}(\mathbb{T}, \mathbb{R})$. If f is continuous at each right-dense and left-dense point, then f is said to be a continuous function on \mathbb{T} , the set of continuous function will be denoted by $C(\mathbb{T})$.

Definition 2.3 (see [31]). For $x : \mathbb{T} \to \mathbb{R}$, one defines the delta derivative of x(t), $x^{\Delta}(t)$ to be the number (if it exists) with the property that for a given $\varepsilon > 0$, there exists a neighborhood U of t such that

$$\left| \left[x(\sigma(t)) - x(t) \right] - x^{\Delta}(t) \left[\sigma(t) - s \right] \right| \le \varepsilon |\sigma(t) - s|, \tag{2.2}$$

for all $s \in U$.

Definition 2.4 (see [31]). If $F^{\Delta}(t) = f(t)$, then one defines the delta integral by

$$\int_{a}^{t} f(s)\Delta s = F(t) - F(a). \tag{2.3}$$

Definition 2.5 (see [33]). For each $t \in \mathbb{T}$, let N be a neighborhood of t. Then, one defines the generalized derivative (or dini derivative), $D^+u^{\Delta}(t)$ to mean that, given $\varepsilon > 0$, there exists a right neighborhood $N(\varepsilon) \subset N$ of t such that

$$\frac{u(\sigma(t)) - u(s)}{\mu(t,s)} < D^+ u^{\Delta}(t) + \varepsilon, \tag{2.4}$$

for each $s \in N(\varepsilon)$, s > t, where $\mu(t, s) = \sigma(t) - s$.

In case t is right-scattered and u(t) is continuous at t, this reduces to

$$D^{+}u^{\Delta}(t) = \frac{u(\sigma(t)) - u(t)}{\sigma(t) - t}.$$

Similar to [34], we will give the definition of anti-periodic function on a time scale as following.

Definition 2.6. Let $\mathbb{T} \neq \mathbb{R}$ be a periodic time scale with period p. One says that the function $f: \mathbb{T} \to \mathbb{R}$ is $\omega/2$ -anti-periodic if there exists a natural number n such that $\omega/2 = np$, $f(t + \omega/2) = -f(t)$ for all $t \in \mathbb{T}$ and ω is the smallest number such that $f(t + \omega/2) = -f(t)$.

If $\mathbb{T} = \mathbb{R}$, one says that f is $\omega/2$ -anti-periodic if $\omega/2$ is the smallest positive number such that $f(t + \omega/2) = -f(t)$ for all $t \in \mathbb{T}$.

Definition 2.7 (see [31]). A function $p: \mathbb{T} \to \mathbb{R}$ is called regressive if $1 + \mu(t)p(t) \neq 0$ for all $t \in \mathbb{T}^k$, where $\mu(t) = \sigma(t) - t$ is the graininess function. If p is regressive and right-dense continuous function, then the generalized exponential function e_p is defined by

$$e_p(t,s) = \exp\left\{\int_s^t \xi_{\mu(\tau)}(p(\tau))\Delta\tau\right\},\tag{2.6}$$

for $s, t \in \mathbb{T}$, with the cylinder transformation

$$\xi_h(z) = \begin{cases} \frac{\text{Log}(1+hz)}{h}, & \text{if } h \neq 0, \\ z, & \text{if } h = 0. \end{cases}$$

Let $p, q : \mathbb{T} \to \mathbb{R}$ be two regressive functions, we define

$$p \oplus q := p + q + \mu p q, \quad \ominus p := -\frac{p}{1 + \mu p}, \quad p \ominus q = p \oplus (\ominus q).$$

Then the generalized exponential function has the following properties.

Lemma 2.8 (see [31, 32]). Assume that $p, q : \mathbb{T} \to \mathbb{R}$ are two regressive functions, then

- (i) $e_0(t,s) \equiv 1$ and $e_n(t,t) \equiv 1$;
- (ii) $e_p(\sigma(t), s) = (1 + \mu(t)p(t))e_p(t, s);$
- (iii) $e_n(t, \sigma(s)) = e_n(t, s)/(1 + \mu(s)p(s));$
- (iv) $1/e_p(t,s) = e_{\ominus p}(t,s);$
- (v) $e_p(t,s) = 1/e_p(s,t) = e_{\ominus p}(s,t)$;
- (vi) $e_p(t,s)e_p(s,r) = e_p(t,r)$;
- (vii) $e_p^{\Delta}(\cdot, s) = pe_p(\cdot, s)$.

Lemma 2.9 (see [31]). Assume that $f, g : \mathbb{T} \to \mathbb{R}$ are delta differentiable at $t \in \mathbb{T}^k$. Then

$$(fg)^{\Delta}(t) = f^{\Delta}(t)g(t) + f(\sigma(t))g^{\Delta}(t) = f(t)g^{\Delta}(t) + f^{\Delta}(t)g(\sigma(t)). \tag{2.9}$$

The following lemmas can be found in [35, 36], respectively.

Lemma 2.10. Let $t_1, t_2 \in [0, w]_{\mathbb{T}}$. If $x : \mathbb{T} \to \mathbb{R}$ is ω -periodic, then

Lemma 2.11. *Let* $a, b \in \mathbb{T}$. *For rd-continuous functions* $f, g : [a, b] \to \mathbb{R}$, *one has*

Definition 2.12. The anti-periodic solution $x^*(t) = (x_1^*(t), x_2^*(t), \dots, x_n^*(t))^T$ of system (1.1) is said to be globally exponentially stable if there exist positive constants ϵ and $M = M(\epsilon) \ge 1$,

for any solution $x(t) = (x_1(t), x_2(t), \dots, x_n(t))^T$ of system (1.1) with the initial value $\phi(t) = (\phi_1(t), \phi_2(t), \dots, \phi_n(t))^T \in C(E_T, \mathbb{R}^n)$, such that

$$\sum_{i=1}^{n} \left| x_i(t) - x_i^*(t) \right| \le M(\epsilon) e_{\Theta \epsilon}(t, \alpha) \left\| \phi - x^* \right\|, \tag{2.12}$$

where

The following continuation theorem of coincidence degree theory is crucial in the arguments of our main results.

Lemma 2.13 (see [37]). Let \mathbb{X} , \mathbb{X} be two Banach spaces, $\Omega \subset \mathbb{X}$ be open bounded and symmetric with $0 \in \Omega$. Suppose that $L : D(L) \subset \mathbb{X} \to \mathbb{Y}$ is a linear Fredholm operator of index zero with $D(L) \cap \overline{\Omega} \neq \emptyset$ and $N : \overline{\Omega} \to \mathbb{Y}$ is L-compact. Further, one also assumes that

(H)
$$Lx - Nx \neq \lambda(-Lx - N(-x))$$
 for all $x \in D(L) \cap \partial \Omega$, $\lambda \in (0,1]$.

Then the equation Lx = Nx has at least one solution on $D(L) \cap \overline{\Omega}$.

3. Existence of Antiperiodic Solutions

In this section, by using Lemma 2.13, we will study the existence of at least one anti-periodic solution of (1.1).

Theorem 3.1. Assume that (H_1) – (H_4) hold. Suppose further that

 (H_5) $E = (e_{ij})_{n \times n}$ is a nonsingular M matrix, where, for $i, j = 1, 2, \ldots, n$,

Then system (1.1) has at least one $\omega/2$ -anti-periodic solution.

Proof. Let $C^k[0,\omega;t_1,\ldots,t_q,t_{q+1},\ldots,t_{2q}]_{\mathbb{T}}=\{x:[0,\omega]_{\mathbb{T}}\to\mathbb{R}^{n+m}|x^k(t)\text{ is a piecewise continuous map with first-class discontinuity points in }[0,\omega]_{\mathbb{T}}\cap\{t_k\}$, and at each discontinuity point it is continuous on the left}. Take

It is easy to see that

$$\operatorname{Ker} L = \{0\}, \qquad \operatorname{Im} L = \left\{ z = (f, C_1, \dots, C_q) \in \mathbb{Y} : \int_0^{\omega} f(s) \Delta s = 0 \right\} = \mathbb{Y}. \tag{3.7}$$

Thus, dim KerL=0= codim ImL, and L is a linear Fredholm mapping of index zero. Define the projectors $P: \mathbb{X} \to \text{Ker } L$ and $Q: \mathbb{Y} \to \mathbb{Y}$ by

Similar to the proof of Theorem 3.1 in [38], it is not difficult to show that $QN(\overline{\Omega})$, $K_P(I-Q)N(\overline{\Omega})$ are relatively compact for any open bounded set $\Omega \subset \mathbb{X}$. Therefore, N is L-compact on $\overline{\Omega}$ for any open bounded set $\Omega \subset \mathbb{X}$.

Corresponding to the operator equation $Lx - Nx = \lambda(-Lx - N(-x)), \lambda \in (0,1]$, we have

Set $t_0 = t_0^+ = 0$, $t_{2q+1} = \omega$, in view of (3.13), (H_1) – (H_4) and Lemma 2.11, we obtain that

4. Global Exponential Stability of Antiperiodic Solution

Since $M(\epsilon) \ge 1$, from Definition 2.12, the $\omega/2$ -anti-periodic solution of system (1.1) is globally exponential stable. This completes the proof.

5. An Example

Example 5.1. Consider the following impulsive generalized neural networks:

$$x^{\Delta}(t) = A(t, x(t))[B(t, x(t)) + F(t, x_t)], \quad t \in \mathbb{T}, \ t \neq t_k,$$

$$\Delta x(t_k) = x(t_k^+) - x(t_k^-) = I_k(x(t_k)), \quad t = t_k, \ k \in \mathbb{Z},$$

where

$$A(t,u) = \operatorname{diag} \left\{ 10 + \frac{2}{\pi} \arctan |u|, 11 + \frac{2}{\pi} \arctan |u| \right\},$$

$$B(t,u) = \frac{1}{100} \binom{u}{u}, F(t,x_t) = \begin{pmatrix} \sum_{j=1}^{2} c_i(t) g_j(x_{jt}) \\ \sum_{j=1}^{2} c_i(t) g_j(x_{jt}) \end{pmatrix},$$

$$\sum_{j=1}^{2} c_i(t) g_j(x_{jt}) \end{pmatrix},$$

when $\mathbb{T} = \mathbb{R}$, system (5.1) has at least one exponentially stable π -anti-periodic solution.

Proof. By calculation, we have $a_1^m=10$, $a_1^M=11$, $a_2^m=11$, $a_2^m=12$, $L_1^a=L_2^a=2/\pi$, $L_1^b=L_2^b=1/100$, $c_1^M=1/1000$, $c_2^M=1/1000$, $L_{11}^I=L_{21}^I=L_{12}^I=L_{12}^I=L_{22}^I=1/500$, and $\mu_1=\mu_2=1/100$. It is obvious that $(H_1)-(H_4)$, $(H_6)-(H_8)$, and (H_{10}) are satisfied. Furthermore, we can easily calculate that

$$E \approx \begin{pmatrix} 7.52 & -12.74 \\ -11.25 & 3.61 \end{pmatrix} \tag{5.3}$$

is a nonsingular M matrix, thus (H_5) is satisfied.

When $\mathbb{T} = \mathbb{R}$, $\mu(t) = 0$. Take $\epsilon = 0.01$, $\theta = -1$, we have that

$$\Psi_1(\epsilon, t) \approx -0.04 < 0, \qquad \Psi_2(\epsilon, t) \approx -0.03 < 0.$$
 (5.4)

Hence (H_{10}) holds. By Theorems 3.1 and 4.1, system (5.1) has at least one exponentially stable π -anti-periodic solution. This completes the proof.

6. Conclusions

Using the time scales calculus theory, the coincidence degree theory, and the Lyapunov functional method, we obtain sufficient conditions for the existence and global exponential stability of anti-periodic solutions for a class of generalized neural networks with impulses and arbitrary delays. This class of generalized neural networks include many continuous or discrete time neural networks such as, Hopfield type neural networks, cellular neural networks, Cohen-Grossberg neural networks, and so on. To the best of our knowledge, the known results about the existence of anti-periodic solutions for neural networks are all done by a similar analytic method, and only good for neural networks without impulse. Our results obtained in this paper are completely new even if the time scale $\mathbb{T} = \mathbb{R}$ or \mathbb{Z} and are of great significance in designs and applications of globally stable anti-periodic Cohen-Grossberg neural networks with delays and impulses .
